RACING INCIDENTS
(117 - 122)

TRACK CONDITION: GOOD GOING

PENETROMETER READING: 3.1 CMS

RAILING POSITION: RAILINGS PLACED AT AN AVERAGE WIDTH OF 6 METRES FROM 1400 METRES UPTO THE WINNING POST FROM ITS ORIGINAL POSITION.

1st Race: 117. The Prince of Troy Handicap - (About) 1000 metres. Horses rated 00 to 25(Whips not allowed) (10 Runners).

PRINCESS SAARAA (N Murugan) was permitted to be withdrawn on veterinary grounds as the mare was suffering from left hind hoof abscess. Trainer R.Karthik was informed to get his charge certified fit by the Club's Veterinary Officer before next accepting with it.

OBSESSION (A S .Peter) jumped awkwardly out at the start and went across BRIGHT LIGHT (C Umesh), the former losing about 2 lengths.

BAY OF NAPLES (M.S.Deora) jumped awkwardly out losing about a length. Jockey M.S.Deora, the rider of BAY OF NAPLES reported that his mount got keen negotiating the 650 metres bend despite his efforts, shifted out and bumped AZERIA (Inayat). The incident being accidental no action was initiated.

The Club's Veterinary Officer reported after the race that OBSESSION (AS.Peter) had sustained a superficial injury of upper gum.

Routine Sample was taken for analysis from the winner BAY OF NAPLES (M.S.Deora).

2nd Race: 118. The Ocean Wish Handicap - (About) 1400 metres. Horses rated 20 to 45, 4 years old only (11 Runners).

PROPOSED (P.Sai Kumar) jumped awkwardly out and forced out RECKONING (A S .Peter) at the start. The incident being accidental no action was initiated.

Jockey D S Deora, the rider of EXCELLENT STAR was fined a sum of Rs.1000/- for shifting out immediately after the start forcing out MARANELLO (G.Sai Vamsi).

Jockey P Trevor, the rider of SABATINI reported that his mount was running green after entering the straight. The Club's Veterinary Officer when asked to examine the filly reported that no abnormalities were found

Jockey P.Vikram, the rider of ROKA was fined a sum of Rs.1000/- for maintaining an erratic course in the straight for no apparent reason. The Club's Veterinary Officer when asked to examine the filly reported that no abnormalities were found.

Routine Sample was taken for analysis from the winner PROPOSED (P.Sai Kumar).

3rd Race: 119. The Brezhnev Handicap - (About) 1200 metres. Horses rated 20 to 45, 5 years old only (12 Runners).

Permission was granted to Trainer Ramanathan R to declare Jockey Shahar Babu, to ride SENORA BIANCA in place of Jockey M.Basker who was indisposed and could not fulfil his riding engagement for the day.

An objection was lodged by Jockey M.S.Deora, the rider of SUNDAY WARRIOR placed 3rd by the Judge against Jockey Ashhad Asbar, the rider of PACIFIC the winner for "***In the last 200 metres when I had a clear run to make my move, the winner came on to me and completely broke my stride, and had to stop riding which cost me a certain race.***" The Stewards interviewed both the Jockeys' and after viewing the cctv replay of the race several times decided to overrule the objection, the Judges placings remained unaltered. However Jockey Ashhad Asbar, the rider of PACIFIC was fined a sum of Rs.2000/- for shifting in under the use of whip causing a check to SUNDAY WARRIOR (M.S.Deora) passing the 200 metres.

Jockey Yash Narredu, the rider of GLORIOUS SUNSHINE was fined a sum of Rs.2000/- for shifting out under use of the whip forcing out PROTEA (C Umesh) from the 350 metres till passing the 200 metres.

Jockey C Umesh, the rider of PROTEA was fined a sum of Rs.2000/- for shifting in passing the 150 metres forcing in GLORIOUS SUNSHINE (Yash Narredu) who shifted in bumped and forced in LORD OF THE TURF (Nakhat Singh).

The Clubs Veterinary Officer reported after the race that SENORA BIANCA (Shahar Babu) had sustained superficial injury on left fore cannon.

Routine Sample was taken for analysis from the winner PACIFIC (Ashhad Asbar) .

4th Race: 120. The Alaska Handicap - (About) 1200 metres. Horses rated 40 to 65 (12 Runners).

SHALEM (C A Brisson) was very fractious in the stalls and jumped awkwardly in as the start was affected

BOHEMIAN GRANDEUR (Nakhat Singh) lacked initial speed and stumbled from the hind passing the 800 metres.

Jockey Yash Narredu, the rider of ALEXANDER reported that his mount was hanging in the straight despite jockey's efforts. The Club's Veterinary Officer when asked to examine the gelding reported that he was found to have wolf teeth. Trainer Deepesh Narredu was informed to take remedial measures before next accepting with his charge.

Jockey C Umesh, the rider of MAGNETISM reported that he felt something wrong with his mount whereby he stopped riding. The Club's Veterinary Officer when asked to examine the gelding reported that no abnormalities were found.

Jockey Ramandeep Singh, the rider of EXCELLENT PHOENIX reported that he was denied a clear run in the straight due to the field in front.

MY KINGDOM (P.Sai Kumar) returned lame on left fore after the race. Trainer Ramanathan R was informed to get his charge certified fit by the Club's Veterinary Officer before next accepting with it.

Routine Sample was taken for analysis from the winner WIND SYMBOL (A M Alam).

5th Race: 121. The South India Sprinters Trial Stakes - (About) 1200 metres. For Indian Horses 4 Years old & Over (6 Runners).

GODS PLAN was hanging out negotiating the 600 metre bend despite efforts forcing out MZILIKAZI (P Trevor). The Club's Veterinary Officer when asked to examine GODS PLAN (P.Sai Kumar) reported that no abnormalities were found. Trainer Ramanathan R was informed to take remedial measures before next accepting with his charge.

Jockey P Trevor, the rider of MZILIKAZI lost his left stirrup while passing the 250 metres which he regained after a few strides.

Routine Sample was taken for analysis from the winner LEOPARD ROCK (Yash Narredu).

6th Race: 122. The Firecracker Handicap - (About) 1200 metres. Horses rated 20 to 45 (12 Runners).

Jockey Santosh G, the rider of CONSTANT VARIABLE was fined a sum of Rs.1000/- for shifting in immediately after the start forcing in ELEGANT TOUCH (Ramandeep Singh).

Jockey C Umesh, the rider of CARTEL was cautioned severely for accidentally losing his reigns passing the 1100 metres shifting in forcing in GLORIOUS SYMPHONY (Md Farhan Alam) who further shifted in forcing in AIR MARSHALL (Nikhil Naidu) who dropped back by 3 lengths.

Jockey Shahar Babu, the rider of ARAKARA was cautioned for shifting in tightening and inconveniencing PROUD (Ashhad Asbar) passing the 800 metres.

CARTEL (C Umesh) dropped back passing the 200 metres. The Club's Veterinary Officer when asked to examine the colt reported that no abnormalities were found.

Routine Sample was taken for analysis from the winner ANDROMEDA SKY (Nakhat Singh).

OBSESSION (A S .Peter) Fly jumped awkwardly.
BAY OF NAPLES (M.S.Deora) Jumped awkwardly.

2nd Race: 118. The Ocean Wish Handicap (About) 1400 Metres

PROPOSED (P.Sai Kumar) and SABATINI (P Trevor) Jumped awkwardly.
MARANELLO (G.Sai Vamsi) Slowly away.

3rd Race: 119. The Brezhnev Handicap (About) 1200 Metres

PACIFIC (Ashhad Asbar) and KING ROGER (Md Farhan Alam) Jumped awkwardly.
EPISTOIARY (G Manikandan) Slowly away.

4th Race: 120. The Alaska Handicap (About) 1200 Metres

BOHEMIAN GRANDEUR (Nakhat Singh) Lost about a couple of lengths. Advised gate practise.

6th Race: 122. The Firecracker Handicap (About) 1200 Metres

CARTEL (C Umesh) and ANDROMEDA SKY (Nakhat Singh) Jumped awkwardly.
