**15TH DAY , THURSDAY, 10TH FEBRUARY 2022**  
**RACING INCIDENTS**  
**(111 - 116)**

**TRACK CONDITION:** GOOD GOING

**PENETROMETER READING:** 3.5 CMS

**RAILING POSITION:** RAILINGS PLACED AT AN AVERAGE WIDTH OF 8 METRES FROM 1200 METRES UPTO THE WINNING POST FROM ITS ORIGINAL POSITION.

**1<sup>st</sup> Race: 111. The Minute To Win It Handicap - Div. II - (About) 1400 metres. Horses rated 20 to 45 (10 Runners).**

RAISINA (C S Jodha) was slow to start losing about 2 lengths.

PALSY WALSY (Shrikant Kamble) ducked and then fly jumped awkwardly losing about 2 lengths at the start

SONIC DASH (Yash Narredu) ducked as the start was affected losing about 2 lengths.

SALVADOR (P.Vikram) dropped back entering the straight and ran detached. The Club's Veterinary Officer when asked to examine the horse reported that no abnormalities were found. Trainer James Mckeown was informed to ensure better performance of his charge before next accepting with it.

Jockey P.Sai Kumar, the rider of DEMESTHENES was fined a sum of Rs.1000/- for shifting in passing the 500 metres causing a check to ATTICA (A S .Peter) travelling on the inner rails.

The Club's Veterinary Officer reported after the race that GOLDEN STREAK (Inayat) was suffering from sore back. Trainer J.Sebastian was informed to get his charge certified fit by the Club's Veterinary Officer before next accepting with it .

Compulsory sample was taken for analysis from PALSY WALSY (Shrikant Kamble). Routine Sample was taken for analysis from the winner UNCLE SAM (Ashhad Asbar).

**2<sup>nd</sup> Race: 112. The Minute To Win It Handicap - Div. I - (About) 1400 metres. Horses rated 20 to 45 (11 Runners).**

TRENDING PRINCESS (Nikhil Naidu) planted. Starting Stall Certificate revoked.

LAKSHANAM (A M Alam) jumped awkwardly outwards and drifted wide out losing about 3 lengths in the process.

Jockey D S Deora, the rider of FLYING SAFE was fined a sum of Rs.2000/- for shifting in passing the 300 metres causing interference to MEZCAL (P.Vikram).

The Club's Veterinary Officer reported after the race that FLYING SAFE (D S Deora) had lost left Fore shoe during the race.

Routine Sample was taken for analysis from the winner SUCCESSION (Yash Narredu).

**3<sup>rd</sup> Race: 113. The MSRM .Meyyappan Chettiar Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65 (11 Runners).**

LIVE BY NIGHT (P.Sai Kumar) planted, did not raise a gallop ran detached and took no practical part in the race. Starting Stall Certificate revoked.,

SANTA CLARA (C S Jodha) was hanging in, in the straight despite jockey's efforts. The Club's Veterinary Officer when asked to examine the filly reported that no abnormalities were found. Trainer Adhiraj Singh Jodha was informed to take remedial measures before next accepting with his charge.

Jockey Dharshan Antony, the rider of KNIGHT IN ARMOUR was cautioned for shifting out soon after the start forcing out MR KOOL (C Umesh).

The Club's Veterinary Officer reported that LADY MIMI (Yash Narredu) was suffering from sore back. Trainer Deepesh Narredu was informed to get his charge certified fit by the Club's Veterinary Officer before next accepting with it.

Routine Sample was taken for analysis from the winner SANTA CLARA (C S Jodha).

**4<sup>th</sup> Race: 114. The G.Kasturi Memorial Cup - (About) 1200 metres. For Maiden Horses 3 Years old only (11 Runners).**

RADIANT JOY (Shrikant Kamble) jumped awkwardly inwards at the start.

SAINT EMILION (D S Deora) was slow to start losing about 2 lengths.

Jockey A S .Peter, the rider of THE REBEL was severely cautioned for dropping his hands before passing the post, despite on a beaten horse.

Jockey P.Sai Kumar, the rider of LEBUA reported that his mount was lugging out for major part of the race. The Club's Veterinary Officer when asked to examine the filly reported that she was trotting lame on left fore due to high suspensory desmitis during examination on 11/2/2022. Trainer Ramanathan R was informed to get his charge certified fit by the Club's Veterinary Officer before next accepting with it.

Jockey C A Brisson, the rider of DARK SON was fined a sum of Rs.1000/- for shifting in under use of the whip, passing the 350 metres, forcing in BERRETTINI (A Imran Khan). The Club's Veterinary when asked to examine DARK SON (C A Brisson) reported that no abnormalities were found.

Routine Sample was taken for analysis from the winner STILL I RISE (C Umesh).

**5<sup>th</sup> Race: 115. The Chief Justice Trophy - (About) 1800 metres. Horses rated 40 to 85 (8 Runners).**

ANGELINO (NR.Santosh Raj ) fly jumped awkwardly at the start losing about a length.

SPICY STAR (Santosh G) jumped awkwardly inwards and forced in SPEED AIR (Yash Narredu).

Routine Sample was taken for analysis from the winner EMELDA (A Imran Khan).

**6<sup>th</sup> Race: 116. The Secret Talk Handicap - (About) 1400 metres. Horses rated 00 to 25, 5 years old and over (10 Runners).**

DIVA PRINCESS (A M Alam) fly jumped awkwardly at the start.

LADY BLAZER (A S .Peter)and WELCOME CHAKKARAM (C A Brisson)were slow to start losing a length each.

An objection was lodged by Jockey A S .Peter, the rider of LADY BLAZER placed 4th by the Judge against Jockey C A Brisson, the rider of WELCOME CHAKKARAM placed 3rd by the Judge for "***In the last 11/2 furlongs my horse was moving well ,C.A.Brisson came out, whereby I had to check my mount, causing me lose a certain place***". The Stewards interviewed both the Jockeys 'and after viewing the cctv replay of the race several times decided to overrule the objection.

An objection was lodged by the rider of horse no 3 SIFAN (Aman) placed 2nd by the Judge against the rider of horse no 4 MAJESTIC CHARMER (C Umesh) placed 1st by the Judge for "***While I was making my move in the last 150 metres, the rider of winner came onto me, while whipping on his right, and did not correct his horse, causing me to stop riding and losing my momentum, and I lost a certain race.***" The Stewards interviewed both the Jockeys' and after viewing the cctv replay of the race several times, decided to uphold the objection and revised the order of placings as follows:

No 3	SIFAN	(Aman)	-	1st
No 4	MAJESTIC CHARMER	(C Umesh)	-	2nd
No 8	WELCOME CHAKKARAM	(C A Brisson)	-	3rd
No 2	LADY BLAZER	(A S .Peter)	-	4th

Further Jockey C Umesh, the rider of MAJESTIC CHARMER was fined a sum of Rs.3000/- for shifting wide out under use of the whip forcing out SIFAN (Aman) in the final stages of the race.

Trainer N.Rupa was fined a sum of Rs.5,000/- for improved performance of her charge MAJESTIC CHARMER (C Umesh) placed close 2<sup>nd</sup> in this race as compared to his previous run in Race no.86 run on 27<sup>th</sup> January 2022 where the gelding had finished 8<sup>th</sup> out of 12 runners.

Routine Sample was taken for analysis from the winner SIFAN (Aman).

TRENDING PRINCESS (Nikhil Naidu) Planted.SSC revoked.

LAKSHANAM (A M Alam) Jumped awkwardly out and veered out after the start.

##### **3rd Race: 113. The MSRM .Meyyappan Chettiar Memorial Trophy (About) 1400 Metres**

LIVE BY NIGHT (P.Sai Kumar) Planted.SSC revoked.

##### **4th Race: 114. The G.Kasturi Memorial Cup (About) 1200 Metres**

RADIANT JOY (Shrikant Kamble) Jumped awkwardly.

LEBUA (P.Sai Kumar) Jumped awkwardly.

SAINT EMILION (D S Deora) Slowly away.

##### **5th Race: 115. The Chief Justice Trophy (About) 1800 Metres**

ANGELINO (NR.Santosh Raj ) Fly jumped awkwardly.

SPICY STAR (Santosh G) Jumped awkwardly.

##### **6th Race: 116. The Secret Talk Handicap (About) 1400 Metres**

DIVA PRINCESS (A M Alam) Fly jumped awkwardly.

LADY BLAZER (A S .Peter) and WELCOME CHAKKARAM (C A Brisson) Slowly away.
