RAILING POSITION : RAILINGS PLACED AT ITS ORIGINAL POSITION

1st Race: 106. The Delhi Race Club Cup - (About) 1400 metres. Horses rated 20 to 45 (9 Runners).

BEAUTEOUS MAXIMUS (Sah Farid Ansari) was slow to start by 2 to 3 lengths.

Jockey Ashhad Asbar, the rider of UNCLE SAM was fined a sum of Rs.2000/- for weighing out late with respect to his mount UNCLE SAM and cautioned for turning his head repeatedly passing the 550 metres.

Jockey P.Sai Kumar, the rider of SHIELD MAIDEN was fined a sum of Rs.2000/- for excessive use of the whip.

Routine Sample was taken for analysis from the winner GLORIOUS SUNSHINE (Nikhil Naidu).

2nd Race: 107. The Bangalore Turf Club Cup - Div. II - (About) 1200 metres. Horses rated 20 to 45 (10 Runners).

MAYFLOWER (Yash Narredu) jumped awkwardly outwards and went across CHOIR (Ramandeep Singh) at the start.

SUBJUCATE (Kuldeep Singh) drawn 7 jumped awkwardly outwards and CHARLIEZ ANGEL (A Ayaz Khan) drawn 9 jumped awkwardly inwards causing a check to ANTIGUA (Ashhad Asbar), the latter losing 3 to 4 lengths.

Jockey Kuldeep Singh, the rider of SUBJUCATE was fined a sum of Rs.2000/-for dropping his hands well before passing the winning post.

An Enquiry has been opened into the running and riding of ANTIGUA ridden by Jockey Ashhad Asbar and trained by Mr.Anil Kumar. The Club's Veterinary Officer when asked to examine the filly reported that she was found to have Right Arytenoids chondropathy on endoscopic examination.

Routine Sample was taken for analysis from the winner FULL OF SURPRISE (Mukesh Kumar (hyd)).

3rd Race: 108. The Bangalore Turf Club Cup - Div. I - (About) 1200 metres. Horses rated 20 to 45 (9 Runners).

PROTEA (C A Brisson) jumped awkwardly inwards forcing in EL POLITICO (S.Sunil) at the start.

Jockey Ashhad Asbar, the rider of PACIFIC was fined a sum of Rs.2000/- for shifting in soon after the start causing interference to PROTEA (C A Brisson).

Jockey C A Brisson, the rider of PROTEA was fined a sum of Rs.2000/- for excessive use of the whip.

An enquiry has been opened into the running and riding of EMPRESS ETERNAL trained by Mr.R.Foley and ridden by Jockey Nakhat Singh.

Routine Sample was taken for analysis from the winner PACIFIC (Ashhad Asbar).

4th Race: 109. The Royal Western India Turf Club Ltd. Cup - (About) 1200 metres. For Maiden Horses 3 Years old only (8 Runners).

MY TRIUMPH (C A Brisson) was fractious and reluctant to be stalled despite all efforts and was permitted to be withdrawn before coming under the starters orders, Starting Stall Certificate revoked. As the gelding had shown similar behaviour in its previous start, Trainer B.Suresh was informed not to accept with his charge until its behaviour improved to the satisfaction of the Stipendiary Stewards in a mock race on the race track on a race day.

LAKSHANAM (Nikhil Naidu) fly jumped awkwardly and threw her head around soon after the start losing about 2 to 3 lengths.

Jockey Yash Narredu, the rider of ROGER O'MORE reported that he felt something wrong with his mount passing the 1100 metres therefore he did not ride out and took no practical part in the race. The Club's Veterinary Officer on examination of the colt reported that no abnormalities were found.

Routine Sample was taken for analysis from the winner DASHING BEAUTY (P Trevor).

5th Race: 110. The Turf Authorities Cup - (About) 1400 metres. Horses rated 60 to 85 (10 Runners).

NOBLE HEIR (G Manikandan) was withdrawn on veterinary grounds (trotting lame on both hind) before coming under the starters orders. Trainer P.Krishna was informed to get his charge certified by the Club's Veterinary Officer before next accepting with it.

STAR ELEGANT (Ajeet Kumar (Mys)) was reluctant to be trotted to the gates and thus delayed the proceedings. Trainer Dhruv Kumar Futnani was informed to school his charge before next accepting with it.

STAR ELEGANT (Ajeet Kumar (Mys)) was slow to start by 4 to 5 lengths. Jockey reported his mount got keen negotiating the final bend and drifted wide out entering the straight and then veered in passing the 350 metres. The Club's Veterinary Officer on examination of the gelding reported that no abnormalities were found. Trainer Dhruv Kumar Futnani was informed to take remedial measures before next accepting with it.

BEETHOVAN (Yash Narredu) was observed to drop back entering the straight. The Club's Veterinary Officer when asked to examine BEETHOVAN (Yash Narredu) reported that no abnormalities were found.

Routine Sample was taken for analysis from the winner NIGHT HUNT (Gaurav Singh).

6th Race: 111. The Nilgiris Gold Cup - (About) 1600 metres. For Indian Horses, 4 Years old & Over (8 Runners).

Jockey Nikhil Naidu, the rider of VACHAN reported that the saddle used on his mount shifted to the left soon after the start whereby he could not ride out and hence shifted out to prevent being a

hindrance to the field. Trainer Rakesh was fined a sum of Rs.3000/- for negligence in the discharge of his duties as a licensed professional with respect to his charge VACHAN (Nikhil Naidu).

Routine Sample was taken for analysis from the winner BORN QUEEN (P Trevor).

7th Race: 112. The Coromandel Gromor Nilgiris Derby Stakes (GR-I) - (About) 1600 metres. For 3 Year old Indian Horses (Foaled in 2018) (9 Runners).

CHASHNI (Nikhil Naidu) fly jumped at the start.

ALICIA (P S Chouhan) jumped awkwardly inwards.

MITSURO (Arshad Alam) was slow to start losing about a length.

COOL RIDER (A Sandesh) put his head down as soon as the starting gates opened and thereafter jumped out slowly losing about 4 to 5 lengths. Further, Jockey reported that the horse tired out in the final stages of the race. The Club's Veterinary Officer when asked to examine the gelding reported that no abnormalities were found.

Compulsory Sample was taken for analysis from the winner ALICIA (P S Chouhan), ALL ATTRACTIVE (P Trevor) placed 2nd and KNOTTY DANCER (Mukesh Kumar (hyd)) placed 3rd.

8th Race: 113. The Hyderabad Race Club Cup - (About) 1600 metres. Horses rated 40 to 65 (9 Runners).

ROMAN SENATOR (P.Sai Kumar) was slow to start by 5 to 6 lengths and then jumped awkwardly and veered out dislodging the rider.

COMANCHE BRAVE (Nakhat Singh) was slow to start losing about 2 lengths.

Routine Sample was taken for analysis from the winner MR KOOL (Nikhil Naidu).

BEAUTEOUS MAXIMUS (Sah Farid Ansari) Lost about a couple of lengths. Advised gate practise.

MAYFLOWER (Yash Narredu) Jumped out awkwardly

4th Race: 109. The Royal Western India Turf Club Ltd. Cup (About) 1200 Metres

MY TRIUMPH (C A Brisson) Reluctant to be stalled. Withdrawn.SSC revoked.

5th Race: 110. The Turf Authorities Cup (About) 1400 Metres

STAR ELEGANT (Ajeet Kumar (Mys) Lost about 4-5 lengths. Advised gate practise.

7th Race: 112. The Coromandel Gromor Nilgiris Derby Stakes (GRADE-I) (About) 1600 Metres

COOL RIDER (A Sandesh) Lost about 4-5 lengths. Horse put his head down immediately as the start was affected. Advised gate practise.

8th Race: 113. The Hyderabad Race Club Cup (About) 1600 Metres

ROMAN SENATOR (P.Sai Kumar) Planted. SSC revoked.

RACE NO.167, THE GRYFFINDOR PLATE, FOR HORSES RATED 00 TO 25, 5 YEARS OLD & OVER, DISTANCE ABOUT 1200 METRES.

The Stewards of Madras Race Club at their meeting held on Saturday, 18th September 2021 after viewing the CCTV replay of the race multiple times, considering the Stipendiary Stewards note, the Charge sheet issued to Jockey Azfar Syeed and after having questioned both Jockey Azfar Syeed and Trainer Mr.K.S.Mandanna, The Stewards came to a conclusion that Jockey Azfar Syeed was in breach of Rule 159(b) and Trainer Mr.K.S.Mandanna was in breach of Rule 114(b)(i) of the Madras Race Club Rules of Racing and resolved to:

- Withdraw the 'A' Jockey's License granted to Jockey Mr.Azfar Syeed and declare him a disqualified person from 28th September 2021 upto 31st March 2022(both days inclusive),for breach of Rule 159(b) of the Madras Race Club Rules of Racing for his ride on THREE OF A KIND in Race no.167 run on 5th March 2021.
- To fine Trainer Mr.K.S.Mandanna a sum of Rs.25,000/- for negligence in the discharge of his duties pertaining to his charge THREE OF A KIND, as a licensed professional for breach of Rule 114 (b) (i) of The Madras Race Club Rules of Racing.

During the period 28th September 2021 to 31st March 2022(both days inclusive) Jockey Azfar Syeed shall be treated as a disqualified person and shall be subject to all disabilities under the MRC Rules of Racing for a disqualified person.

The Jockey was informed of his right to appeal to The Board of Appeal in terms of Rule no.46(a).

**RACE NO.72, THE SHINING FORCE HANDICAP, FOR HORSES RATED 20 TO 45, 4
YEARS OLD ONLY, DISTANCE ABOUT 1200 METRES.**

The Stewards at their meeting held on Saturday, 18th September 2021 after viewing the CCTV replay of the race multiple times, considering the Stipendiary Stewards note, the Charge sheet issued to Jockey Azfar Syeed and after having questioned Jockey Azfar Syeed and Trainer Mr.K.S.Mandanna, The Stewards came to a conclusion that Jockey Azfar Syeed was in breach of Rule 159(b) of the Madras Race Club Rules of Racing and considering that Jockey Azfar Syeed is already a disqualified person under the MRC Rules of Racing from 28th September 2021 till 31st March 2022, The Stewards resolved to:

Declare Jockey Azfar Syeed's a disqualified person from 1st April 2022 upto 30th September 2022 (both days inclusive) for breach of Rule 159(b) of The Madras Race Club Rules of Racing for his ride on MAYFLOWER in Race no.72 run on 2nd September 2021.

During the period 1st April 2022 to 30th September 2022 (both days inclusive) Jockey Azfar Syeed shall be treated as a disqualified person and shall be subject to all disabilities under the MRC Rules of Racing for a disqualified person.

The Jockey was informed of his right to appeal to The Board of Appeal in terms of Rule no.46(a).
