

MADRAS RACES 2023-2024 2Nd EXTRA DAY, THURSDAY, 29TH FEBRUARY 2024 RACING INCIDENTS (207-212)

TRACK CONDITION: GOING GOOD

RPENETROMETER READING: 3.00 CMS

RAILINGS POSITION: THE RAILINGS ARE PLACED AT AN AVERAGE WIDTH OF 2.0 MTRS FROM 1200 MTRS UPTO THE WINNING POST FROM ITS ORIGINAL POSITION

1st Race: 207. The Desmond Handicap - Div. I - (About) 1100 metres. Horses rated 20 to 45(Whips not allowed) (9 Runners).

Permission was granted to Trainer R.Foley to deputise on behalf of Trainer N. Rupa for BEAUTY OF THE TURF (Bharat Mal) and WONDERFUL ERA (Sah Farid Ansari) at both trainers risk and liability.

BEAUTY OF THE TURF (Bharat Mal) burst its blood vessel (EIPH) during the race. Trainer N. Rupa was informed to get her charge certified fit by the Club's Veterinary Officer befoe accepting next with.

Jockey M.S.Deora, the rider of MR STARC was advised to be more careful in his riding by exercising proper control over his mount in riding straight.

RAFFINATO (S.Saqlain) received interference from MR STARC (M.S.Deora) due to which he had to break stride at the 600 metres and accidentally lost balance momentarily which he regained after few strides at the 400 metres.

The Saddle of SEATTLE BLUE (Shah Alam) shifted. Trainer B.Suresh was fined Rs 2000/- for faulty saddling of his charge SEATTLE BLUE (Shah Alam).

The Club's Veterinary Officer reported after the race that MR STARC (M.S.Deora) had sustained superficial injury on left hind inner bulb.

Routine Sample was taken for analysis from the winner FIRST MISSILE (V R Jagadeesh).

2nd Race: 208. The Desmond Handicap - Div. II - (About) 1100 metres. Horses rated 20 to 45(Whips not allowed) (8 Runners).

After veterinary examination on 29/02/2024 at 9.40 pm FIAT JUSTITIA (M.S.Deora) was found to be suffering from Acute Capped elbow of Right fore. Trainer K. S.

Mandanna was informed to get his charge certified fit by the Club's Veterinary Officer before accepting next with.

Permission was granted to Trainer R.Foley to deputise on behalf of Trainer N. Rupa for BOHEMIAN STAR (Sah Farid Ansari) at both trainers risk and liability.

Routine Sample was taken for analysis from the winner LADY WONDER (Ram Nandan Manjhi).

3rd Race: 209. The Hampton Handicap - (About) 1400 metres. Horses rated 00 to 25 (10 Runners).

At the start ALETTA (Ritesh Gochhi) jumped out momentarily lost balance.

ANCOURAGE (A S .Peter) jumped out veering to the left interfering with TOUCH OF FURY (Koshi Kumar) which had to be steadied.

At the start SUNCHE DREAMS (S.Imran) met interference from ALETTA (Ritesh Gochhi) and AIR MARSHALL (L.Alex Rozario).

Routine Sample was taken for analysis from the winner KALLIPOS (Jitendra Singh).

4th Race: 210. The Prince Chevalier Handicap - (About) 1200 metres. Horses rated 60 to 85 (10 Runners).

Jockey Imran Chisty, the rider of DIAMOND AND PEARLS reported that he was repeatedly interfered on the rails by SECRET PEARL (Hindu Singh) and MORISET (Ram Nandan Manjhi) from 600 to 400 metres where he had to stop riding his mount and could not ride out.

Jockey Hindu Singh, the rider of SECRET PEARL was reprimanded and fined Rs 5000/- for not exercising proper control on his mount by allowing to lean on MORISET (Ram Nandan Manjhi) and DIAMOND AND PEARLS (Imran Chisty). He was advised to be more careful in his future rides.

Routine Sample was taken for analysis from the winner STAG'S LEAP (S.Saglain).

5th Race: 211. The Sans Craintes Stud Million - (About) 1200 metres. For Horses 3 Years Old Only (6 Runners).

Permission was granted to Trainer J.Sebastian to deputise on behalf of Trainer Darius Byramji for HELIOS (Imran Chisty) at both trainers risk and liability.

Jockey Imran Chisty, the rider of HELIOS reported that the bay gelding was trying to run out passing the 600 metres and he could not control his mount due to which he had to complete the race on the outer rails. Jockey reported that the gelding was running green and accidentally stumbled near 800 metres.

The Club's Veterinary Officer reported after the race that no abnormalities were found on HELIOS (Imran Chisty).

Routine Sample was taken for analysis from the winner GOLD RIDE (Akshay Kumar).

6th Race: 212. The Milan Mill Handicap - (About) 1400 metres. Horses rated 20 to 45 (11 Runners).

Permission was granted to Trainer Ajith Kumar.v. to deputise on behalf of Trainer Saddam Iqbal for MIDNIGHT SPARKLE (S.Imran) at both trainers risk and liability.

The Club's Veterinary Officer reported after the race that ACANTHA (Hindu Singh) had sustained superficial injury on Right hind fetlock.

The Club's Veterinary Officer reported after the post examination at 6.00pm that RINELLO (Ram Nandan Manjhi) was found to be trotting lame on Right fore. Trainer B. Suresh was informed to get his charge certifed fit by the Club's Veterinary Officer before next accepting with.

Routine Sample was taken for analysis from the winner SALOME (Akshay Kumar).

SHAAS COMRADE (P.Siddaraju) Jumped awkwardly.

2nd Race: 208. The Desmond Handicap - Div. II (About) 1100 Metres

THE STING (Koshi Kumar) Jumped awkwardly.

3rd Race: 209. The Hampton Handicap (About) 1400 Metres

Level Jump

4th Race: 210. The Prince Chevalier Handicap (About) 1200 Metres

SECRET PEARL (Hindu Singh) and SPECULATION (Shah Alam) Jumped awkwardly.

5th Race: 211. The Sans Craintes Stud Million (About) 1200 Metres

KINGS RETURN (Ram Nandan Manjhi) Fly jumped awkwardly.

6th Race: 212. The Milan Mill Handicap (About) 1400 Metres

BLUE EYED BOY (Koshi Kumar) Rearing inside the stalls and dislodged the rider. Hence Withdrawn.

ORDER OF THE STEWARDS

RACE NO.114, THE DANZIG HANDICAP (ABOUT 1200 METERS) FOR HORSES RATED 0 to 25, FOR 5 YEARS OLD AND OVER RUN ON THE NINETEENTH DAY, MONDAY, 1ST JANUARY 2024.

The Stewards of Madras Race Club at their meeting held on Monday, 29th January 2024, considered the Analytical Report received from Quantilab, Mauritius, pertaining to the Analysis of the Urine Sample taken from Ch.m.5 year old, **ROYAL FALCON**(trained by N. Govindarajan), winner in Race No. 114, which had shown the presence of Cobalt, a prohibited substance above the international threshold limit in the sample of the urine which was taken from the said horse, after the race it had won.

The Stewards also noted the following:-

The Trainer was informed of this and was given the option of sending the split sample of the urine of the said horse for confirmatory analysis.

The Trainer N. Govindarajan informed the Club that he would wish to send the split sample of the Urine of the horse to LCH, FRANCE for testing the confirmatory analysis at the Trainer's expenses.

The Stewards of the Club at their meeting held on Sunday, 18th February 2024 considered the split sample report of Ch.m 5 year old ROYAL FALCON received from LCH, France dated (13.02.2024) confirming the presence of "COBALT" above the international threshold limit.

The Stewards of the Club then decided to disqualify the winner, Ch.m 5 year old ROYAL FALCON from The Danzig Handicap run on Monday(01.01.2024) and revised the order of placing as under:-

ORDER OF THE STEWARDS
RACE NO.114 THE DANZIG HANDICAP (ABOUT 1200 METERS)
FOR HORSES RATED 0 to 25, FOR 5 YEARS OLD AND OVER
RUN ON THE NINETEENTH DAY, MONDAY, 1 ST JANUARY 2024

- 1. The Stewards of the Madras Race Club at their meeting held on Sunday, 18 th February2024, considered the split urine sample report received from LCH France dated (13-02-24)pertaining to ch.m. 5 year old, ROYAL FALCON (trained by N.Govindarajan), winner of Race No. 114, The Danzig Handicap run on 1-1-24 ,LCH France lab report confirming the presence of COBALT (prohibited substance class III above the international threshold limit.
- 2. The Stewards of the Club questioned Trainer N.Govindarajan and his son who was present along with to assist the Trainer N.Govindarajan in the enquiry, in view of the reported impairment in his hearing.
- 3. In this connection the Stewards noted the following:
- (a) That Trainer N. Govindarajan had been granted a conditional "A" Licence till March 2022, wherein all his runners participating in the race(s) under his charge will be sampled at

his own expenses.

- (b) That the conditional licence had also been renewed up till 31 st March 2023.
- (c) That the Trainer had breached the Medication rules of Madras Race Club and his Licence been withdrawn from 15/11/2019 to 14/10/2020.
- 4. After deliberations and noting the submissions made by the Chief Stipendiary Steward and

Chief Veterinary Officer and after duly considering the submissions of Trainer N.Govindarajan, the Stewards found Mr.N.Govindarajan guilty of repeatedly breaching the Medication rules of Madras Race Club and taking into account, the current infringement (of prohibited substance) the Stewards of the Club decided as under:-(a) To cancel the conditional "A" Licence issued to Trainer. N.Govindarajan under rule no 41(a) of Madras race Club Rules of Racing with immediate effect. In view of repeated breach of Medication Rules of Madras Race Club, as published in the Calendar

Notification issued by Madras Race Club under the heading, Medication and Treatment

- of Horses in Training and Racing and Anti-Doping Control.
- (b) To consequently invoke the following disabilities which shall be applicable to N. Govindarajan following the cancellation of his licence, by the Stewards of the Madras Race Club:-
- (i) Not permitted to train or own horses under any Turf Authority of India.
- (ii) Not to enter any race course/or attend any race meetings /stables
- (iii) Not to attend track work under any Turf Authority of India.
- (iv) Not to enter the Club House or any other premises of the Madras Race Club.
- (vi) To transfer all the horses under your charge to "A" licenced Trainer under the Madras Race Club Rules of Racing.
